Minutes of the Extra Ordinary Full Council Meeting.

The Council met at 6.00pm on Tuesday 28th January 2025 in Room 8, Leigh Community Centre, 71-73 Elm Road, Leigh-On-Sea, Essex, SS9 1SP.

FC032/25 Apologies for Absence

Apologies were received and agreed for Cllrs P Barber, A Hart and C Watt. Proposed by Cllr B Arscott, seconded by Cllr P Gilson; with 9 for and 1 abstention the motion was passed.

FC033/25 Declarations of Members' Interests

There were no declarations of Disclosable Pecuniary Interests, Other Pecuniary Interests or Registrable Non-Pecuniary Interests.

FC035/25 Private and Confidential

FC036/25 Staffing Matters

The Clerk had circulated confidential emails from the solicitor dated 17th January 2025, 24th January 2025 and 28th January 2025. An in-depth discussion took place regarding the confidential legal matter. All Councillors were able to express their opinions and what they felt was in the best interest of the Council. A proposal from Cllr P Wexham, seconded by Cllr K Evans to continue with the legal process, was put forward. With 3 for, 6 against and 2 abstentions the motion was not passed. A proposal to stick with the maximum financial amount relating to the meeting of the 16th January 2025 was put forward. Proposed by Cllr J Garston, seconded by Cllr P Gilson; with 4 for, 5 against and 2 abstentions the motion was not passed. A proposal for a new financial amount was put forward, proposed by Cllr C Mulroney and seconded by Cllr Dr D Bowry. An amendment was put forward to have a financial range with Cllr C Mulroney's proposed financial amount being the maximum. Proposed by Cllr C Willoughby, seconded by Cllr J Lloyd; with 7 for and 4 against the amendment motion was passed. The original proposal by Cllr C Mulroney was then voted on with the amendment.
