Through its website, bi-annual magazine and through contact with our Volunteer programme to promote recruitment of Specials from within Leigh whilst understanding that these can be deployed elsewhere in times of need.

Report from Cllr Carole Mulroney:

There is deep concern in Leigh at the reduction in PCSO numbers in the Southend area. Leigh has already lost its front desk contact for the community and now will be losing its police station altogether. For a town the size of Leigh to then be left with a very small share of a drastically reduced number of PCSOs leaves a population of 22,000 without a visible presence. We would urge the Essex Police to reconsider this position and additionally increase its Specials contingent so that Leigh can have benefit from their availability and presence.

8. STRAND WHARF TEMPORARY TRAFFIC REGULATION ORDER

The Council have been advised that we require a Temporary Traffic Regulation Order for the construction works on Strand Wharf which are due to start on 14th December 2015. The Chairman, Vice Chairman and Chairman of Policy and Resources have been consulted and that as a matter of urgency the payment of £2,600 has been made.
