# WITHDRAWAL OF BUS SERVICE NUMBERS

With effect from 4<sup>th</sup> September, Arriva Southend are revising all their services operating within South East Essex.

Whilst there will be improvements to services in the Southchurch, Thorpe Bay and Great Wakering areas, Service 5 is being withdrawn.

The route is Southend Central – London Road - Chalkwell Schools - Leigh Road – Leigh Broadway - Rectory Grove - Hadleigh Road – London Road- Hadleigh - Thundersley – Basildon and offers in the region of 26-27 journeys depending on the day.

The only other route which covers the same stops as Service 5 is Regal Busways Service 3, which operates five journeys in each direction on Monday to Saturday, at approximately two-hourly intervals.

First in Essex operates Service 26 between Southend and Hadleigh, with the same route as Service 5 between Southend and Rectory Grove. It then operates via Leigh Station and Thames Drive before returning to London Road. It does not serve three stops in each direction along Hadleigh Road nor the two stops along the London Road covered by bus service number 5. It offers 19 -21 journeys depending on the day. Unfortunately, First in Essex often cancel journeys without notice, particularly in the afternoon.

Within Southend Borough most Service 5 journeys are well used, sometimes even with standing passengers. However, west of Thames Drive there are fewer passengers due to more frequent journeys on other services.

Originally, Service 5 operated only between Southend and Thames Drive. Latterly, it was amalgamated with the former service 2, extending journeys to Basildon.

The withdrawal of Service 5 will cause great inconvenience to Leigh-on-Sea passengers. It is therefore **RECOMMENDED** that the Committee request Arriva to consider running Service 5 between Southend and Thames Drive and that in addition to contacting Arriva Southend, Southend Borough Council Parking, Highways and Transport Department are advised of our concerns.
