## 2017/18 Local Government Finance Settlement

Leigh-on-Sea Town Council was established in 1996 with the intention of providing facilities to the residents of the town and over the intervening years it has been successful in doing so.

Having carefully considered the proposals contained in in the Technical Consultation Paper dated September 2016 the Town Council fully supports the stance of the Essex Association of Local Councils in opposing the extension of council tax referendum to some or all local councils.

As an example in 2012 when faced with the loss of its community centre through local authority cuts the Town Council carried out its own consultation with the people of Leigh as to whether or not they would be prepared to see a rise of £5 in their council tax in order to save the Centre. This they overwhelmingly supported and the Centre now thrives. The cost of this consultation was under £1000 and was very effective.

If the referendum principles were applied to the Council then such an increase would have triggered a referendum costing in the region of £24,000; representing a Band D charge of £2.87 or 57% of the proposed increase and this would apply whether the result was positive or not.

As Town and Parish Council's functions are discretionary there can be differences from year to year causing large percentage changes as funds are raised for specific projects. These large changes in percentages do not necessarily equate to a large financial increase and that is what residents are interested in - percentages provide a false impression to the actual financial increase.

The consultation does not reflect the tremendous amount of work that local councils undertake on behalf of their communities and the closeness that exists between most councils and their residents.

Additionally the consultation does not take into account the diminution of the Local Council Support Grant or the fact that local councils do not receive other funding such as Revenue Support Grant, New Homes Bonus, Non-Domestic Rates or Council Tax Freeze Grant. Council tax therefore represents a much higher proportion of local council income.

At a time when principal authorities have to make cuts that affect services the extension of the referendum principle to town and parish councils will have a counterproductive effect and will reduce even further the amount of services they are able to provide for their local residents or even deter some from doing more in their communities.
