86. ALLOTMENTS NON-RESIDENTS LEVY REPORT - Agenda item 9

The Committee discussed the matter in great detail with questions raised. It was highlighted that the allotments are legally for our own residents but were not like the Council facility of the Community Centre where anyone can enjoy the facility. On the basis that a percentage levy would be difficult to administer and that at this time to only have plot holders from within the Town Council boundary was not feasible, then following a proposal (Cllr Fr. Hillman, seconded Cllr C Mulroney), the Committee **RESOLVED** that a non-resident allotment levy of £20 with effect from September 2020 be the preferred option **to recommend to Council.**

The Committee **NOTED** the report and learnt that Rochford Town Council have recently cancelled their Farmers' Market. Rochford customers would be very welcome at our market and the Council will advertise the Leigh Market in Rochford.

The Committee **RESOLVED** with recommendation to **P&R** Committee the proposed changes to Earmarked reserves at the financial year-end.

RESOLVED that in view of the confidential nature of the business to be transacted the public and press be excluded and instructed to withdraw – SO 3(d) other special reason

95. LOSALGA REPRESENTING THE LEIGH SITE - Agenda item 18

The Committee **NOTED** the report. The Annual Service Agreement at the present time is suspended as there is no LOSALGA committee. Additionally the Clubhouse (Greenhouse) area is shut as there is no LOSALGA committee.

The Committee **RESOLVED** that the investigation without prejudice is concluded. Although the Council are concerned about the finances and administration of LOSALGA, following legal advice, the Council will not involve itself in the way the association operates. That said, until a new committee is formed and follows a correct Constitution and does not compromise the aims of the Allotment Service Agreement, no further ASA money will be paid to LOSALGA.

In this respect, the Council will give the Association three months to effect this. Additionally, only LOSALGA as an Association has been given Permission to Use the Greenhouse area. Therefore should there be evidence after three months that LOSALGA are not fulfilling the aims of the Annual Service Agreement or breach the Licensee's obligation contained with the Permission to Use Agreement, then the Council will terminate the agreements and look to work with another Association.

The Town Clerk will send a detailed letter to all allotment plot holders on the Leigh side showing what steps are to be taken to reinstate the Annual Service Level Agreement with LOSALGA. The Council are happy for the Extra Ordinary meeting of LOSALGA members to form a new committee to take place at the Community Centre and recognises that allotment plot holders will be able to become LOSALGA members on the night prior to the Committee being formed.

The meeting closed 8.40 p.m.
