- The area is not accessible, easily viewable and hidden by shrubs The Town Clerk advised that Friends of Leigh Library Gardens will be working on the area to make improvements
- Children may slip on the mosaic if they run on to it which may cause them to fall into the fencing The Town Clerk advised that the local mosaic design company have installed lots of floor mosaics including one in Colchester. The tiles used are appropriate for walking over.
- Who is liable if someone has an accident The Town Clerk advised that the area is owned and managed by Southend City Council and it is a Friends of Leigh Library Gardens' project. Leigh Town Council are not liable for the area.

The Town Clerk further advised that the Committee could not reverse the decision of the Finance & Governance Committee which was to set aside £5000 of CIL funds for a community project to install a mosaic piece in Library Gardens. Only Finance & Governance Committee or Council could reverse this under the appropriate Standing Order procedures.

The Town Clerk confirmed that a meeting could be arranged with Friends of Leigh Library Gardens.

Following a proposal (Cllr Watt, seconded Cllr Arscott) the Committee **RESOLVED** to pause funding to the Friends of Library Gardens mosaic project until a meeting was held. It was agreed that the Chairman would provide a statement to the Town Clerk to publish. The Council's involvement in the project would be paused too on social media.
